NOTICE OF MAKING OF A STOPPING UP ORDER SECTION 247 TOWN AND COUNTRY PLANNING ACT 1990

NOTICE is hereby given that following the decision of the Deputy Mayor of Planning, Regeneration and Skills of the Greater London Authority on 14th April 2020 under section 252(5A) of the above Act (as amended), that it is unnecessary to hold a Public Inquiry, the London Borough of Barnet (“the Council”) acting in its capacity as a local highway authority, has made an Order under section 247 of the above Act (as amended) entitled **REDEVELOPMENT AT GRANVILLE ROAD ESTATE NW2 (HIGHWAY AT/ADJACENT TO GRANVILLE ROAD (PART), MORTIMER CLOSE (PART) AND LLANELLY ROAD (PART) STOPPING UP ORDER No.1 2020** authorising the stopping up of the areas at / adjacent to Granville Road, Mortimer Close and Llanelly Road as described in the Order and the Schedule attached to the Order.

Any person aggrieved by the making of the Order and desiring to question the validity of the Order (or of any provision contained therein) on the ground that the Order is not within the powers of the above Act or that any requirement of that Act or of any regulation made under the Act has not been complied with in relation to the Order, may, within 6 weeks of the date of this notice apply to the High Court for suspension or quashing of the Order or of any provisions contained therein.
