

THE LONDON BOROUGH OF BARNET (WEST HENDON REGENERATION AREA) COMPULSORY PURCHASE ORDER (No. 2) 2016

THE TOWN AND COUNTRY PLANNING ACT 1990 SECTION 226 (1) (a)

AND THE ACQUISITION OF LAND ACT 1981

AND THE LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1976 SECTION 13

The London Borough of Barnet (in this order called 'the Acquiring Authority') makes the following order:-

1. Subject to the provisions of this order, the Acquiring Authority is under Section 226 (1) (a) of the Town and Country Planning Act 1990 and the Acquisition of Land Act 1981 and the Local Government (Miscellaneous Provisions) Act 1976 hereby authorised to purchase compulsorily the land and the new rights over the land at West Hendon described in paragraphs 2 and 3 for the purpose of facilitating the carrying out of development, redevelopment or improvement on or in relation to the land namely the demolition of existing buildings on the land and the erection of new residential dwellings, associated landscaping and public realm works, associated highway works, associated energy centre and interim works.
2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on the map prepared in duplicate, sealed with the common seal of the Acquiring Authority and marked "Map referred to in the London Borough of Barnet (West Hendon Regeneration Area) Compulsory Purchase Order (No. 2) 2016".
3. The new rights to be purchased compulsorily over land under this order are described in the Schedule and the land is shown coloured blue on the said map.
